Please be aware that there are significant risks associated with outdoor adventures and/or activities. Some risks may be inherent, may occur through human error, or cannot be eliminated without altering the nature of the activity. Thus, before signing, carefully read the statements below. Do not sign unless you understand that there is a risk of severe and/or fatal injury that you are assuming sole responsibility in the event of an injury or death, and you are releasing Snow College from all responsibility.

I, _____ (print participant's name), being at least 18 years of age, understand that the Snow College SnowFun Program activity in which I intend to voluntarily participate involves certain risks and dangers for which I assume full responsibility. These risks and dangers include, but are not limited to, travel to and from an activity, falls, falling rocks, equipment failure, operator or instructor error, acts of nature (i.e. cold or hot weather related injuries and/or variable weather conditions), actions of myself or others, and risks inherent in the activity that cannot be reasonably eliminated. I understand that injuries that may result from my participation in any activities associated with this program or activity may include, but are not limited to, cuts, burns, bruises, sprained joints, broken bones, psychological trauma, infection, and/or death.

I agree to assume responsibility for all risks, including those risks not specifically identified, and acknowledge that my participation in this activity is purely voluntary. I hereby waive all claims and release the State of Utah, Snow College, its officers, employees, agents, and volunteers from any and all liability, claims, demands, actions, and causes of actions whatsoever for any loss, claim, damage, injury, illness, or harm of any kind or nature arising out of participation in activities at Snow College, including harms that occur due to the released parties' negligence.

I elect to participate in spite of the risks and affirm that I am physically and mentally capable of participating in the activities and/or safely using the associated equipment. I agree to notify the program staff if I have any medical condition that may restrict my participation in any way during the program or activity, or if I need reasonable accommodations.

I agree that I will listen to and comply with the instructions of all SnowFun instructors or other Snow College personnel and that I will use all provided safety equipment as instructed.

I certify that I have read this entire document and understand it completely. I also understand ^{OVER →} that it affects my legal rights, that I have waived and release my rights in the event of an injury, and agree to be bound by its terms.
